Earning Recognition







Benchmark Litigation, the definitive guide to elite litigation firms and attorneys throughout North America, once again recognized Willenken and its five partners for their excellence in litigation and client service in 2018. Winning Matters



Total Victory for Major LED Manufacturer in Eight-Figure Cross-Border Dispute

After four years of grueling litigation, Willenken notched an impressive win for its Korea-based client, Lumens Company, Ltd. The LED manufacturer had sued a distributor for nonpayment of over \$1 million worth of LED products shipped to the distributor's customers, to which the distributor responded by filing 15 counterclaims and demanding \$16 million in compensatory and punitive damages. Led by partner **Jason Wilson**, Willenken won Lumens'

breach of contract claim against the distributor on summary judgment in 2015 and later filed motions *in limine* that exposed a fatal flaw in the distributor's case, leading to a court order of simultaneous summary judgment briefing. Senior associate **Amelia Sargent** deftly briefed the simultaneous motions and argued the motions at two hearings, resulting in the court handing Lumens a total victory on all contested issues and disposing of the entire case.

Full Dismissal of Telecommunications Lawsuit

Partner **Paul Loh** and senior associate **Aarti Wilson** delivered a checkmate in the pleadings stage of a complex business matter. Firm client Motorola Solutions, Inc. was sued for unfairly obtaining a federal grant to install a multi-million dollar public safety radio system for the City of Glendora, as the plaintiffs claimed the radio system interfered with their privately licensed radio frequencies. Willenken moved to dismiss, arguing the plaintiffs' claims were preempted by the Federal Communications Act, which led the plaintiffs to change tactics and allege instead that Motorola had violated the Sherman Act.



Undeterred, Willenken filed another motion to dismiss, pointing out that the plaintiffs' antitrust theory suffered a fatal flaw: bid-rigging requires allegations of conspiracies among competitors, and the plaintiffs could not make any such allegations. This, along with additional facts shrewdly discovered by the Willenken team, forced the plaintiffs to dismiss their claims with prejudice.



Favorable Jury Verdict for Reusable Coffee Capsule Company in Patent Infringement Case

Firm client ARM Enterprises was accused by a Seattle-based company of infringing a patent related to reusable capsules for single beverage coffee machines. At trial, the plaintiff sought compensatory damages of over \$1.5 million and a finding of willfulness, which would have trebled damages to \$4.5 million and supported the plaintiff's motion for attorneys' fees. Partner **Will Delgado's** cross-examination of the plaintiff's damages expert at trial pointed out the errors in the expert's Georgia Pacific analysis. During

closing argument, Will seized on numerous concessions by the plaintiff's expert and other witnesses to argue that its damages analysis was vastly overinflated. Because of Will's strategic defense, the jury awarded a mere \$192,000 in compensatory damages and found that ARM Enterprises had not willfully infringed the patent.

Partners **Eileen Ahern, Paul Loh,** and **Megan O'Neill** hosted a Lunch and Learn for members of the Association of Corporate Counsel (ACC) Minnesota Chapter in June, at which they presented a substantive checklist for in-house counsel to use for their defense when a class action is filed. Eileen and Megan shared similar tips on a panel, moderated by senior associate **Justin Goodwin,** at the ACC Washington Chapter 2nd Annual Business Summit in September. The same day, Paul led a panel detailing how to obtain an optimal and efficient settlement without going to trial for members of the ACC Southwest Ohio Chapter (*pictured left*), which was followed by a social hour and brewery tour.

At the National Association of Minority and Women-Owned Law Firms (NAMWOLF) 2018 Business Meeting in February, partner **Megan O'Neill** spoke on a panel about "Social Networking: Dos & Don'ts – A Discussion Regarding Business Development, Trending Ethical Considerations & Privacy Breach."


Articles
