represented The Bird Nest, LLC, an entity owned by Katy Perry, in a real estate and contract dispute matter. She helped secure The Bird Nest, LLC's right to acquire a former convent from the Roman Catholic Archdiocese of Los Angeles for redevelopment into a residential compound. Breeanna also helped defeat the claims of a competing buyer and the cancellation of the competing buyer's recorded deed and other clouds on title, as well as secured a verdict of \$15 million against the competing buyer.

The following is a representative sample of Breeanna's casework:

- *AbbVie Endocrine, Inc. v. Takeda Pharmaceutical Company*. As a member of a 100%-diverse trial team in "one of the five big healthcare lawsuits" of the year, secured a favorable ruling on behalf of AbbVie Endocrine, Inc. in a high-stakes breach of contract case against Takeda Pharmaceutical Co. Breeanna assisted in developing questioning and defense of multiple expert and percipient witnesses during the trial in Delaware Chancery Court, and in phase two, Breeanna assisted in orchestrating the damages strategy resulting in a \$448 million judgment. Pre- and post-judgment interest were set by stipulated judgment, in which Takeda waived its right to appeal.

brought a patent infringement lawsuit in the District Court of Colorado, where based upon arguments presented during the *Markman* hearing and the underlying briefing, the court adopted substantially all of the firm's proposed constructions for seven contested terms of eight patent claims, which placed our client in an extremely advantageous position for a successful settlement obtained just days before trial.

- *Bird Nest, LLC v. Competing Buyer*. Secured the right to acquire a former convent from the Roman Catholic Archdiocese of Los Angeles for redevelopment into a residential compound and, in the process, defeated the claims of a competing buyer (hotel developer). As a member of the trial team, Breeanna helped develop questioning and defense of multiple party and percipient witnesses and assisted in orchestrating the damages strategy resulting in a \$15 million verdict against the competing buyer.
- *Thompson v. Enfants Riches Deprimes, LLC*. Obtained a favorable settlement for a punk-influenced luxury fashion label against a former accountant and business manager for fraud, breach of fiduciary duty, breach of contract, and accounting malpractice. Breeanna drafted a motion to compel that was granted and secured the production of documents previously withheld through analysis of metadata.
- *Global Software Corporation v. Former Executive*. Represented and successfully defended high-level software engineering executive against wide-ranging allegations of trade secret misappropriation and breach of a confidentiality agreement brought by a global software giant when he left for a competitor start-up. After a pre-litigation remediation overseen by a third-party neutral, all allegations were dropped and settled on favorable terms to the client.
- *Individual Users v. Social Media Company*. Aided in motion practice in trial court on behalf of a social media company in Section 230 cases.
- *Individual User v. Prominent Streaming Service*. Aided in motion practice in trial court on behalf of a prominent streaming service in a trademark and copyright infringement case.
- *Individual Consumers v. Major Automotive Company*.
