## Kenneth's Biography

Kenneth Trujillo-Jamison is the managing partner of Willenken LLP. At trial, Kenneth examined and defended multiple expert witnesses. The court ultimately awarded a judgment that, with prejudgment interest, exceeded \$500 million.

Kenneth also has deep experience litigating entertainment matters. For example, Kenneth was part of a team that achieved a total defense verdict for Disney and Pixar in a copyright infringement case involving the film "Moana." He also represented a prominent portrait photographer in a right-of-publicity case brought by the rapper Jay-Z.

And Kenneth has convinced judges in numerous cases across the country to dismiss on the pleadings copyright infringement claims involving motion pictures, ending those matters before discovery.

Kenneth also is experienced defending technology companies in litigation about users and user-generated content posted on their platforms. He has obtained dismissal, on Communications Decency Act grounds, of several cases seeking to hold a prominent social media company liable for claims arising from the suspension of users from its platform.

Kenneth also has experience in consumer class actions. He has, for example, represented Procter & Gamble in a dispute involving claims of unfair and deceptive labelling for a popular body wash product, and Mattel and Fisher-Price in false advertising cases involving a popular infant product. Kenneth also has experience counseling Southern California Gas Company on regulatory issues before the California Public Utilities Commission.

Aside from his practice, Kenneth is a leader in the Los Angeles legal community.
